Race-day registration will begin at 8:30 a.m. at Hollis-Brookline High School, 24 Cavalier Court, Hollis, N.H. Number pick-up for pre-registrations will also take place at the High School.

**Course:** The two-mile route will begin and end at Hollis-Brookline High School, 24 Cavalier Ct., Hollis, N.H. Start on Cavalier Ct. and proceed to Pepperell Rd./Main Street. Turn left onto Pepperell Rd./Main St. Turn right onto Monument Square Rd. and bear right at the monument to Depot Rd. Proceed south on Depot Rd. for approximately .7 mile. Turn right onto Merrill Lane and proceed to Pepperell Rd./Main St. Turn right onto Pepperell Rd./Main St. and turn left onto Cavalier Ct. to the finish line.

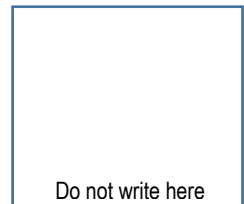
